Lindsay and Mark Henderson – A Personal Story

“Lindsay and I feel like we’re making a difference. We’re still feeling our way around a bit, but we’re starting to really learn the neighborhood and all the client stops,” says Mark Henderson. His wife Lindsay sits beside him in the passenger seat, thumbing through the Route Book to determine the next client on the delivery schedule, as he maneuvers the car through Greek Town side streets. What springs to mind — as they talk about the rigor of being in their fifth year of a six-year doctoral program at The Johns Hopkins Medical Institutions — is that old adage: “If you want something done, ask a busy person to do it.”

They met at Hopkins on the first day of classes and ended up working in labs that have a common focus on Cystic Fibrosis. Mark is in Cellular and Molecular Medicine and Lindsay is fighting the disease through a Human Genetics disciplinary track. She’s from Minnesota, while Mark’s roots are in rural New Jersey. From all appearances, and as we converse along the meal delivery route, it is evident that they are not only committed to each other, but to a common perception about what’s important and what is not, as well as what should be a common cause for everyone — helping others.

“It was back in high school, in Sussex County, New Jersey, when I first began to see a big, unmet need — people just weren’t getting the food they needed every day. We decided to take a look at the issue and wound up starting a soup kitchen that still serves about 250 people a week. It’s called Harvest House — actually, Lindsay and I went back there this past Thanksgiving and served dinner to everyone,” says Mark. “I kept up that interest through college, but also shifted toward isolation and loneliness issues among the elderly.”

Lindsay’s commitment sprang from the work she used to do in a nursing home. Part of her job was to serve meals to the residents. The nursing home also prepared meals for people who were homebound, so she became familiar with the whole concept of a home-delivered meal service. “I helped put the lunches together and made sure the homebound clients got what they needed,” says Lindsay. “But delivering meals to our clients, one-on-one, visiting and talking with them, is what I really enjoy.” Both agreed that their flexible work schedules at Hopkins enable them to volunteer for Meals on Wheels.

The Hendersons got married in late 2008 and settled into a residence on Fleet Street, close to Hopkins’ East Baltimore medical campus. They started to look for a volunteer opportunity and decided to check out Meals on Wheels’ web site after driving by the building on Haven Street. They signed on as volunteers in early 2009 and now deliver every other Tuesday. When we caught up with them it was only the fourth time on their meal delivery route. They both say that their experiences have been positive and that it’s a great feeling, not only to be of service, but to be able to thread some of their past into their current lives — together.
